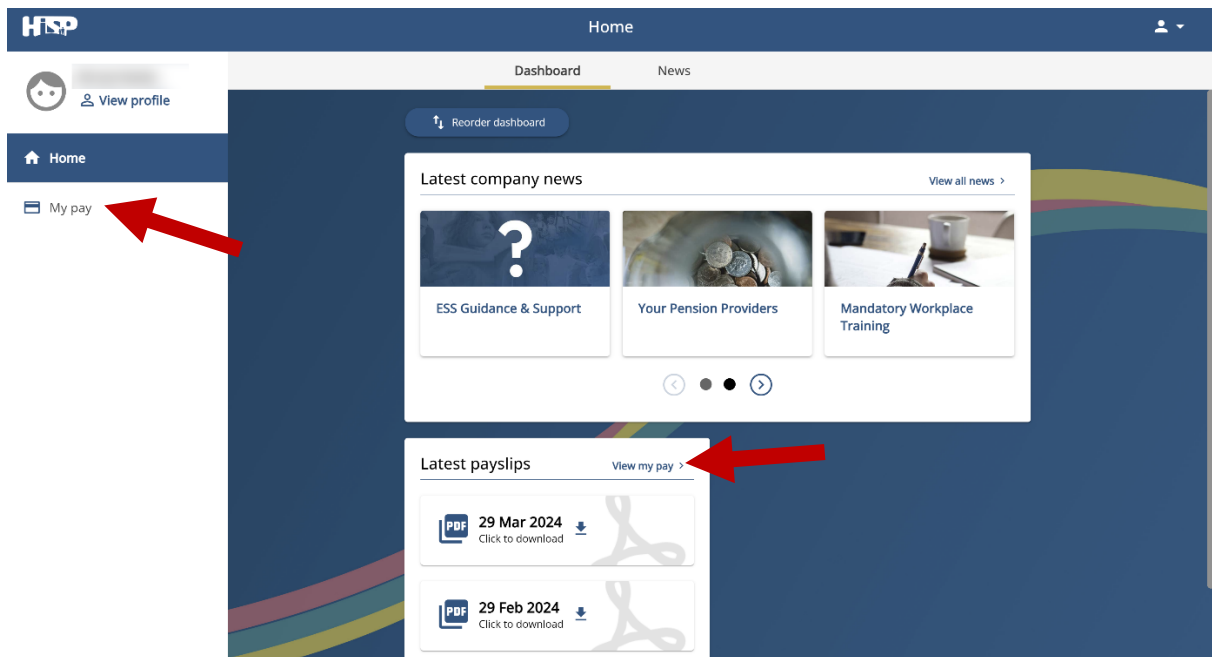
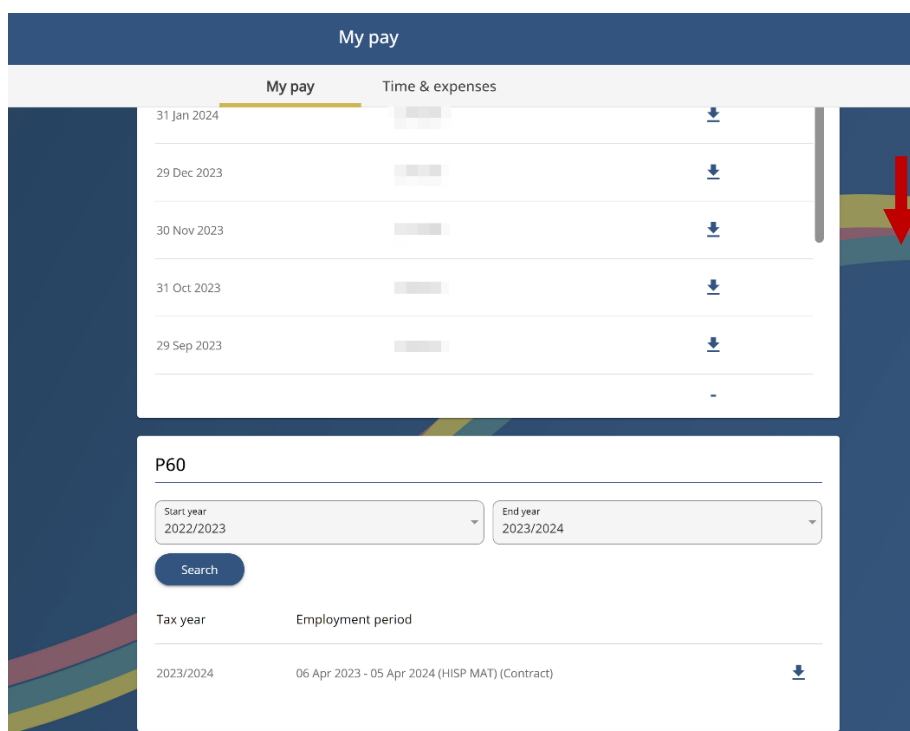


You can access your P60 in one of two ways.
