Dear Parents and Stakeholders

As a Multi Academy Trust (MAT), HISP is ambitious to grow with the intention of supporting more pupils/students, families, staff and communities, and to challenging ourselves that everything we do should improve opportunities for our learners. Growth is considered and measured as we seek like-minded partner schools who share a similar vision. Since Portswood Primary School and Tanners Brook Primary School joined Thornden Secondary School within HISP MAT in July 2020, we have built capacity as an organisation by successfully adding The Solent Maths Hub (solentmathshub.org.uk/), 2 Teaching School Hubs (hispteachingschoolhub.org/) and now the Science Learning Partnership (stem.org.uk/local-cpd) to our wider Learning Partnership designations. These add to our Research School (researchschool.org.uk/hisp) and School Centred Initial Teacher Training (hampshirescitt.org.uk/) in enabling us to be at the forefront of supporting colleagues into teaching and then meeting their developmental needs as they move forward through their careers. The designation of these partnerships supports colleagues across the region, while also being able to use them internally to support our schools and staff. This in turn supports the progress our students/children make.

With this capacity we are able and ready to invite additional schools to join HISP MAT and have been talking with like-minded leaders and governors to form partnerships and consider formalising some of the links we have made. At this point in time, we are working closely with Highcliffe School in Christchurch 11-18 (highcliffe.school/), Isle of Wight Education Federation (IWEF - Carisbrooke College, Medina College and The Island VI Form) 11-18 (iwef.org.uk) and Test Valley School in Stockbridge 11-16 (testvalley.hants.sch.uk/), who are sharing information with their parents and stakeholders in relation to them joining HISP MAT. Collectively we feel there are many benefits to formalising these connections and are excited about the additional opportunities this will create.

We believe there are many benefits to be achieved with Highcliffe, Test Valley and IWEF joining HISP MAT:

- High quality governance with a clear focus on strategic development, leadership, teaching and learning, and accountability
- Building growth and sustainability through strategic succession planning
